Answers to Your Most Common Questions

1. What is 10-Year Group Term Life Insurance? How does it work?

Term Life coverage is the purest kind of life insurance, meaning there are no costly savings features. This 10-Year Group Term Life Insurance is life insurance coverage that can be purchased at a level rate for ten years. 2. What Happens at the End of the Initial 10-Year Period?

You can receive 50% of your (or your insured spouse's) benefit amount before death if you (or your insured spouse) are diagnosed as terminally ill. A terminal illness is a medical condition where the patient has a life expectancy of 12 months or less.
